A Motion was carried out by Council Member Jeff Dorn and seconded by Council Member Ami Dorn to nominate Sheila Faske as Mayor Pro-Tem. Motion carried unanimously.

**AMENDMENT TO THE INSTALLATION OF COUNCIL MEMBER**

**COUNCIL APPROVED THE ADOPTING OF THE HOMESTEAD EXEMPTIONS FOR 2025**
